



Child Safe Code of Conduct

Policy

All staff and volunteers of Broadmeadows PS are required to observe child safe principles and expectations for appropriate behaviour towards and in the company of children, as noted below.

All personnel of Broadmeadows PS are responsible for supporting the safety, participation, wellbeing and empowerment of children by:

- adhering to Broadmeadows PS child safe policy at all times / upholding Broadmeadows PS statement of commitment to child safety at all times
- taking all reasonable steps to protect children from abuse
- treating everyone with respect
- listening and responding to the views and concerns of children, particularly if they are telling you that they or another child has been abused and/or are worried about their safety or the safety of another
- promoting the cultural safety, participation and empowerment of Aboriginal and Torres Strait Islander children (for example, by never questioning an Aboriginal or Torres Strait Islander child's self-identification)
- promoting the cultural safety, participation and empowerment of children with culturally and/or linguistically diverse backgrounds (for example, by having a zero tolerance of discrimination)
- promoting the safety, participation and empowerment of children with a disability (for example, during personal care activities)
- ensuring as far as practicable that adults are not left alone with a child
- reporting any allegations of child abuse to Broadmeadows PS Student Welfare Officer / leadership, and ensuring any allegation is reported to the police or child protection
- reporting any child safety concerns to Broadmeadows PS Student Welfare Officer / leadership
- ensuring as quickly as possible that the child(ren) are safe if an allegation of child abuse is made
- encouraging children to 'have a say' and participate in all relevant organisational activities where possible, especially on issues that are important to them.

Staff and volunteers must not:

- develop any 'special' relationships with children that could be seen as favouritism (for example, the offering of gifts or special treatment for specific children)
- exhibit behaviours with children which may be construed as unnecessary. Holding a child's hand, patting on the back for encouragement and comforting a distressed child can be appropriate.
- put children at risk of abuse (for example, by locking doors)
- do things of a personal nature that a child can do for themselves, such as toileting or changing clothes
- engage in open discussions of a mature or adult nature in the presence of children (for example, personal social activities)
- use inappropriate language in the presence of children
- express personal views on cultures, race or sexuality in the presence of children (facts and law are not opinion)
- discriminate against any child, including because of culture, race, ethnicity or disability
- have contact with a child or their family outside of our organisation without our leadership's knowledge and/or consent (for example, no babysitting).
- have any social online contact with a child or their family
- ignore or disregard any suspected or disclosed child abuse.

By observing these standards you acknowledge your responsibility to immediately report any breach of this code to Broadmeadows PS Student Welfare Officer / leadership.


